- 4. The financial upgradations under the MACPS shall be purely personal to the employees, and shall have no relevance to their seniority position. As such, there shall be no additional financial upgradation for the senior employees on the ground that the junior employee in the grade has got higher pay/grade pay under the MACPS. On grant Page 2 of 3

of financial upgradation under the Scheme, there shall be no change in the designation, classification and status of the employee.

- 5. With regard to fixation of pay on grant of financial upgradation under MACPS, a Govt. servant has an option under FR 22(a)(1) to get his pay fixed in the higher grade pay, either from the date of his upgradation or from the date of his next increment i.e. 1st July of the relevant year. The pay and the date of increment would be fixed in accordance with clarification No. 2 of Deptt. of Expenditure O.M. No. 1/1/2202-IC dated 13.09.2008,No. 35034/3/2008-Estt. (D) dated 16.11.2009 and No. 11 of O.M. No. 35034/3/2008-Estt. (D) dated 09.09.2010. The above upgradation will be subject to terms and conditions stipulated in the Annexures I & II of OM of DoPT referred in unnumberred para-1, as amended from time to time.
- 6. The concerned Heads of Office are advised to re-verify service records of the concerned employee(s) before processing case(s) for pay fixation with above said audit authority. In this regard, any disciplinary case pertaining to service details of the employees should be brought to the notice of this Directorate General within 15 days from the date of issue of this order.
