2. - 2.2 Smt. Vinita Vivek Deshpande (CEO Gp 'B'), empanelled for promotion to JTS for the vacancy year 2015-16, has since retired from Government service on 30.04.2016 on attaining the age of superannuation. Therefore, the officer does not figure in the above given list for promotion
- Consequent to the above and with the approval of the Competent Authority (Director General, Defence Estates), the following transfers/postings (wherever applicable) are ordered:-
