- 2. The National Technical Research Organization vide letter No. V(A)/11/8/Pers (R-I)/NTRO/2018-5675 dated 25.03.2019, has conveyed that the Competent Authority has approved the selection of Smt. Divya S. Hosur (IDES-2011), Chief Executive Officer, Cantt. Consequent, transfer/posting order of officer in view of the ensuing vacancy of the CEO, Cantonment Board, Belgaum has already been issued vide this Directorate General letter No. 134/1/ADM/DE(01)/19(ii) dated 28.05.2019. Smt. Divya S. Hosur may be directed to immediately hand over the officiating charge of CEO, Cantonment Board, Belgaum to Shri Amol B. Jagtap, CEO, Cantonment Board, Kirkee, who will hold the said additional charge in addition to his own in the interim period till the regular incumbent reports to the station.

The leave salary and pension contribution during the period of deputation of the above named officer will be paid by concerned Department/Ministry to the Principal Controller of Defence Accounts (PCDA), HQrs, 'G' Block, New Delhi – 11. Further, the monthly contribution of the officer to Central Government Employee Group Insurance Scheme (CGEGIS) deducted from her salary will be deposited by the concerned Department/Ministry with the PCDA, HQrs.
