**Subject:- Promotion to the Senior Administrative Grade (Rs. 37,400-67,000 in PB-4 + Grade Pay of Rs. 10,000) in Indian Defence Estates Service.**

2. The Appointment Committee of the Cabinet, based on the recommendations of the Department Promotion Committee, has approved the proposal for empanelment of Smt. 4. The promotion of Smt. Shobha Gupta to SAG would be on *ad-hoc* basis, till further orders. The promotion will take effect from the date of assumption of duties in higher charge.



5. Smt. Shobha Gupta, Chief Executive Officer, Cantonment Board, Lucknow Cantt will hand over the charge of the post of CEO, Lucknow to Shri Yogesh Kumar, DEO, Lucknow, who will hold the said charge in addition to his own, till further orders.
