SUB: PROMOTION TO THE SENIOR ADMINISTRATIVE GRADE [₹ 37,400 – 67,000 (PB-4) + GRADE PAY OF ₹ 10,000/- (PRE-REVISED)] IN THE INDIAN DEFENCE ESTATES SERVICE

Reference this Directorate General letters No. 134/1/ADM/DE(2)/16 dated 08.08.2016, and letter of even number dated 05.09.2016

2. Based on the recommendations of the Departmental Promotion Committee, the Appointment Committee of the Cabinet (ACC) has already approved the empanelment of the eligible officers of Indian Defence Estates Service (IDES), including the following two officers for promotion to Senior Administrative Grade (SAG) in the Pay Scale of ₹ 37,400 – 67,000 (PB-4) with Grade Pay of ₹ 10,000/- (pre-revised) for the vacancy year 2016-17, w.e.f. the date of assumption of the charge of the post, and until further orders:-

- (i) **Shri Parshotam Lal**
- (ii) **Ms. Sujatha Gupta**


3. Keeping in view the vacancies available in the grade together with the fact that the empanelled officer(s) on deputation outside the Cadre, have conveyed their unwillingness for premature reversion to the Cadre for picking up promotion to SAG, and other connected facts, the above named IDES officers are promoted on 'ad-hoc' basis to the Senior Administrative Grade (SAG) in the Pay Scale of ₹ 37,400 – 67,000 (PB-4) with Grade Pay of ₹ 10,000/- (pre-revised) w.e.f. the date of assumption of charge in the higher appointment and until further orders.

4. Shri C. Ravindra, who was then on long term NDC course and promoted *in-situ* to SAG vide this Directorate General letter dated 08.08.2016, has now reverted to the cadre after completion of the said course. Further, pro-forma promotion to SAG was granted to Shri Saurav Ray, consequent upon promotion of Shri Sanjeev Kumar to the grade vide this Directorate General letter dated 05.09.2016. However, Shri Sanjeev Kumar has not yet assumed charge in the SAG. Meanwhile, Shri Saurav Ray, reverted to the Cadre on completion of his deputation tenure and was taken on proforma strength of this Directorate General, against an existing vacancy in SAG in the Cadre, pending orders of the Competent Authority regarding his posting.

5. Accordingly, the following are ordered with the approval of the Competent Authority (Hon'ble Raksha Mantri):-

- (i) **Shri C. Ravindra (IDES-1993)**, is posted as Director, National Institute of Defence Estates Management (NIDEM), Delhi Cantt, against an existing vacancy;
- (ii) **Shri Saurav Ray (IDES-1994)**, is posted as Director in the Directorate of Defence Estates, Eastern Command, Kolkata, against an existing vacancy;
- (iii) **Shri Sanjeev Kumar (IDES-1996)**, who was earlier posted as Director in the Directorate of Defence Estates, Northern Command, Jammu on his promotion to SAG on ad-hoc basis, vide this Directorate General letter of even number dated 05.09.2016, is now diverted and posted as Director in the Directorate of Defence Estates, Southern Command, Pune, against an existing vacancy;
- (iv) **Shri Parshotam Lal (IDES-1996)**, Joint Director in the Directorate of Defence Estates, Eastern Command, Kolkata, upon promotion to SAG, is transferred and posted as Director in the Directorate of Defence Estates, Northern Command, Jammu, against an existing vacancy; and
- (v) **Ms. Sujatha Gupta (IDES-1997)**, Chief Executive Officer, Cantonment Board, Secunderabad, upon promotion to SAG, is transferred and posted as Director, Defence Estates, Western Command, Chandigarh, against an existing vacancy.

6. Consequent to the above and in accordance with the instructions governing the 'Next Below Rule' (NBR) envisaged in the second proviso to F.R. 30(I) read with the instructions contained in DoP&T OM No.8/4/84-Estt.(Pay-I) dated 15.07.1985, **Shri Rakesh Mittal (IDES-1995)** and **Ms. Nigar Fatima Husain (IDES-1996)**, presently, both on deputation outside the Cadre, are granted proforma promotion to the Senior Administrative Grade (SAG) in the Pay Scale of ₹ 37,400 – 67,000 (PB-4) with Grade Pay of ₹ 10,000/- (pre-revised) with effect from the date any one of junior officers, namely, Shri Sanjeev Kumar or Shri Parshotam Lal or Ms. Sujatha Gupta, assume charge in the SAG.




7. As a sequel to the above, following transfers/postings and administrative arrangements are ordered with the approval of the Competent Authority (Director General, Defence Estates):-

- (i) **Shri S.V.R. Chandra Sekhar**, DEO, Secunderabad Circle, is transferred and posted as Chief Executive Officer, Cantonment Board, Secunderabad, vice Ms. Sujatha Gupta, transferred on promotion. He would hand over the charge of DEO, Secunderabad to Shri Vinit S. Nair, Addl. DEO, Secunderabad, who will hold the said charge, in addition to his own, till further orders.

8. TA/DA and joining time will be admissible as per Rules.

9. The dates of assumption of duties shall be intimated to this Directorate General immediately.

10. This issues with the approval of the Director General, Defence Estates.
