2. The Appointments Committee of the Cabinet, based on the recommendations of the Departmental Promotion Committee, has approved empanelment of the following officers of Indian Defence Estates Service (IDES) for promotion to Senior Administrative Grade (SAG) in the Pay Scale Level-14 [pre-revised Pay Scale of $\stackrel{?}{=}$ 37,400 – 67,000 (PB-4) with Grade Pay of $\stackrel{?}{=}$ 10,000/-] on the supplementary panel for the year 2018-19, with effect from the date of assumption of the charge of the post, and until further orders:-

3. The ACC has further approved that the promotions of officers mentioned above recommended by the DPC for the Supplementary Panel year 2018-19 would be on 'ad-hoc' basis till the sealed cover cases are finalized, or subsequent regular vacancies in the grade arise, whichever is earlier.

- 4. The recommendations of ACC in respect of the officers mentioned at Sr. No. 1 & 2 (i.e. Shri D.N. Yadav & Shri Amol B. Jagtap) have been implemented vide this Directorate General letter under reference.
- **5**. Keeping in view the vacancies available in the grade together with the fact that the empanelled officer, namely, Shri K.V. Nagireddy, who is presently on deputation outside the Cadre, has conveyed his unwillingness for premature reversion to the Cadre for picking up promotion to SAG, and other connected facts, **Shri Ravi Shankar (IDES:1998)**, who is presently also on deputation outside the cadre and conveyed his willingness for premature repatriation to the Cadre for picking up the promotion to SAG in Cadre, is promoted on 'ad-hoc' basis to the Senior Administrative Grade (SAG) in the Pay Scale Level-14 [pre-revised Pay Scale of ₹ 37,400 − 67,000 (PB-4) with Grade Pay of ₹ 10,000/-] w.e.f. the date of assumption of charge in the higher appointment and until further orders.
- **6.** Consequent to the above, **Shri K.V. Nagireddy**, presently on deputation outside the Cadre, is granted Pro forma Promotion to the Senior Administrative Grade (SAG) in the Pay Scale Level-14 [pre-revised Pay scale of ₹ 37,400 − 67,000 (PB-4) with Grade Pay of ₹ 10,000/-] under Next Below Rule (NBR) with effect from the date of his junior, namely, Shri Ravi Shankar, draws officiating pay in that scale.
- 7. Accordingly, the following transfer/postings of SAG level officers are ordered with the approval of the Competent Authority (Hon'ble Raksha Mantri):-
 - (i) Shri Valeti Premchand (IDES-1994), presently on proforma strength of this Directorate General, consequent upon reversion from deputation, and after completion of terminal leave on 05.09.2019, is posted as Director, in the Directorate of Defence Estates, Central Command, Lucknow, against an existing vacancy; and
 - (ii) Shri Ravi Shankar (IDES:1998), on premature reversion from deputation consequent upon ad-hoc promotion to SAG, is posted as Additional Director General in the Directorate General of Defence Estates, Delhi Cantt, against an existing vacancy.
- 8. TA/DA and joining time will be admissible as per Rules.
- **9.** The dates of assumption of duties shall be intimated to this Directorate General immediately.
- 10. This issues with the approval of the Director General, Defence Estates.
