Reference this Dte. Gen. letter No. letter No. 142/5/ADM/DE/CR/09/Vol-X/A (FMS-68298) dated 27.05.2022, No. 142/5/ADM/DE/CR/09 (FMS-68298) dated 13.07.2022 and letter No. 142/5/ADM/DE/CR/09 / Part File(FMS-68298) dated 22.11.2022.

2. This Directorate General vide letter under reference had allocated 89 newly recruited SDO-II to all the Directorates for doing the needful. Further, Dte. DE EC Kolkata, Dte. DE, WC, Chandigarh, Dte. DE, NC, Jammu, Dte. DE, SC, Pune and Dte. DE, CC, Lucknow reported that 08 of the 89 allocated candidates allocated under their jurisdiction, were either not reported for document verification or resigned from service. Accordingly, this Dte. Gen. vide letter under reference allocated another 08 candidates from reserve list for their appointment to the post of SDO-II in different offices as per request of directorates.

3. Again, Dte. DE EC Kolkata, Dte. DE, NC, Jammu, Dte. DE, SC, Pune and Dte. DE, CC, Lucknow have reported that 07 more candidates have either not reported for document verification or resigned from service. As per instructions contained in DoP&T OM No. 41019/18/97-Estt(B) dated 13.06.2000, vacancies resulting from resignation /refusal/death of the incumbents within one year of appointment may be filled by the candidate from the reserve panel. Accordingly, following candidates from reserve panel are approved by the Competent Authority (i.e. DG, DE) against the station mentioned below:

Being the Appointing Authority for the post of Sub-Divisional Officer Grade-II, carrying Level-4 of the pay matrix (Group 'C' post), the Directorates concerned, are requested to verify the particulars/ documents of the candidates comprehensively before issuing offer of appointment to the above mentioned candidates.

5. Dte. DE, SC, Pune is requested to forward original dossiers of the above named candidate to the concerned directorates wherein candidates have been allocated.

6. Furthermore, the concerned candidates who are to be appointed through reserve list may be suitably informed regarding their selection. The candidates be also apprised that they will be required to attend the forthcoming Rozgar Mela along with copy of their appointment letter. The details of the same will be intimated as per directions received from Ministry of Defence.

7. Specific instructions regarding forthcoming Rozgar Mela would also be conveyed separately after receipt of the same from MoD/DoP&T.
