

GENERAL INSTRUCTIONS FOR EXAMINATION FOR THE POST OF SDO-II

1. The written examination for selection to the post of SDO-II will be held on **26.02.2017 at 10:00 AM in Madhyamik Vidhyalaya, R.A. Bazar, Topkhana, Lucknow Cantt.** The approximate distance from Charbagh Railway Station to the examination centre is 04 kms. No candidate will be allowed to enter in the Examination Hall after commencement of the examination. Once entered in the Examination Hall the candidates will not be allowed to leave the examination hall, before 12:00 Hrs. The candidates will occupy their allotted seat in their respective rooms positively by 9:30 Hrs.

2. **Exam Pattern** - shall comprise Written Test and Skill Test.

(i) **Written Test-** The written exam for SDO-II shall be held on **26.02.2017** and shall comprise of Objective Type Test for 170 Marks. The paper shall be of 02 hours duration from 10:00 AM to 12:00 Hrs. The details of exam are as under-

(ii) **Skill Test-** 'Skill test, to be conducted from **27.02.2017** onwards for those candidates who are shortlisted after Written Test, will be given in handling ETS/DGPS/GPS and other practical aspects of land survey of 30 marks. The skill test for the post of SDO-II will be of qualifying nature. Minimum qualifying marks in skill test will be 33%, which is **essential** and candidates who do not obtain said minimum qualifying marks in skill test will not be assessed for the final result. However, final assessment will not be done on the basis of marks obtained in skill test.'


3. Candidate may note that candidature is provisional, subject to verification of original documents which does not give any claim of the candidate over the post.

4. Photographs/Signatures/Thumb impressions are liable to be verified before the written test.

5. The **shortlisted candidates** in the written test will be allowed to appear in the Skill Test which shall be held from **27.02.2017 at 10:00 hrs** in **venue of which will be informed on 26.02.2017 to all candidates.**

6. List of Shortlisted Candidates in the written test will be displayed on the notice board of Madhyamik Vidhyalaya, R A Bazar, Topkhana, Lucknow and in the office of Principal Director, Defence Estates, Central Command, 17 Cariappa Road, Lucknow Cantt after **6:00 pm on 26.02.2017.**

7. All the HH candidates shall submit their disability certificate in original either in English or in Hindi as per Annexure-I to DOPT OM No. 36035/3/2004-Estt. (RES) dated 29.12.2005 (copy enclosed), which should be countersigned by the Medical Superintendent /CMO/Head of the Hospital (with seal) **before the Written Exam.** Please note that PH (HH) candidates who do not produce the above certificate will not be allowed to take part in the said exam.

If any malpractice is detected at any stage, including impersonation, his application is liable to be rejected with serious consequences. No mobile phone, calculator, paper, etc. will be allowed in the Examination Hall.

12. After the examination is over, the Question/Answer Booklets shall be handed over to the Examination Hall invigilator. If the Candidate is found to be carrying the booklet, answer sheets outside examination hall, his candidature will be summarily cancelled.


13. The final merit list will be drawn up on the basis of Written Exam and subject to having obtained qualifying marks in the Skill Test.

14. List of qualifying candidates who would be recommended for selection to the post of SDO-II in form of a panel after the Skill Test will be displayed on the notice board of Madhyamik Vidhyalaya, RA Bazar, Topkhana, Lucknow Cantt and in the office of Principal Director, Defence Estates, Central Command, 17 Cariappa Road, Lucknow Cantt. on **the day of completion of skill test at 1800 hrs.** The said result will also be available on the website of following offices:-
